Position Title:	Aboriginal Health Worker ICD Clinic
Classification:	Stream D - Direct Service Delivery, Band 1

Purpose of the Role

The Aboriginal Health Worker will support the coordination and delivery of the Indigenous Chronic Disease Clinic (ICD) and as directed other programs within the Primary Health Services Portfolio. This will include supporting the Primary Health services team to improve health outcomes for those accessing chronic disease management and prevention services within the portfolio. This role will proactively work with First Nations communities and external stakeholders to increase engagement and referrals within designated regions aligned to Marathon Health programs and initiatives, whilst educating providers about services delivered by Marathon Health.

Key Relationships

The Aboriginal Health Worker reports directly to the Portfolio Manager, Chronic Disease Services and is a member of the Primary Health Team. They will closely collaborate with clinical staff and project staff within the Primary Health team to support them with community and stakeholder engagement engagement such as with GPs and Practice Nurses, schools, social service organisations, local government and peak bodies to facilitate collaborative care of First Nations clients.

Position Responsibilities

Responsibilities for this position include, but are not limited to:

- Support clinicians with client intake, assessment, follow-up and discharge processes.
- Facilitate group sessions, including delivery of culturally safe and engaging health education sessions and yarning circles
- Maintain client electronic medical records where appropriate
- Provide program specific administration and coordination support where required
- Encourage and support First Nations people to access health and related services
- Support clinicians to complete the required assessments and surveys for evaluation
- Facilitate telehealth sessions between clients and clinicians.
- Provide timely feedback to referring clinicians and maintain regular communication with the client's broader primary health care team.
- Identify barriers for local First Nations individuals and families to access health services and work with the Primary Health team to address these barriers where appropriate.
- Provision of culturally appropriate patient and community education in order to improve consumer health literacy.
- Maintain client confidentiality at all times.
- Assist to manage risks associated with the delivery of primary health services
- Assist to implement quality improvement activities to improve primary health services

Essential

- Identify as First Nations
- Demonstrated high standard of interpersonal and communication skills, including the ability to adapt services to meet varying cultural needs.
- Experience working with First Nations communities
- Minimum Cert 3 qualification in Aboriginal Health/Community/Disability
- Have strong communication skills and be able to develop relationships with First Nations people within the community.
- Knowledge of service providers in local area.
- Experience in working both independently and as part of a team to achieve continual results.
- Sound computer skills and the ability to adapt to new software applications.
- An understanding of how to identify, support and guide First Nations community members with chronic health concerns to appropriate referral pathways.

Desirable

- Experience in chronic disease management and prevention.
- Strong understanding of local community and available health services.
